HOW TO OPEN A FIXED TERM DEPOSIT ACCOUNT

1. CONTACT US:

2. BOOK AN APPOINTMENT:

After your initial inquiry, one of our Relationship Managers will schedule an appointment with you at our Head Office to guide you through the onboarding process.

As part of the onboarding process, please prepare and make sure to have the following documents ready with you when visiting for your appointment:

1. A copy of your identity card or Passport (*front and back*)
2. Recent Bank statements, or proof of source of wealth
3. [Source of Wealth Declaration Form](#)
4. [Statement of Affairs](#) (*on a case by case basis*)
5. [Term Deposit Form](#)
6. Bank Mandate – [Joint](#) or [Individual](#) (*depending on your account preference*)
7. [Personal Tax Declaration](#)

If the documents are not completed prior to your appointment or if you need assistance with them, our Relationship Managers will be help you complete them during your meeting. Fixed Term Deposits are covered by the Depositor Compensation Scheme up to €100,000.

This coverage is in line with the European Union's Deposit Guarantee Schemes Directive, which ensures protection for depositors. Kindly refer to the following for more information: [Depositor Compensation Scheme Clause](#).

Once all documentation has been submitted and approved by the Bank, it will take a maximum of 5 working days to open your account.

A minimum deposit of €10,000 is required to open a fixed-term deposit account, and no service fees are applicable.

After the account is successfully opened, your Relationship Manager will provide you with your IBAN details. You can then proceed to deposit the funds via one of the following methods:

- Prepare a Bank Draft payable to FIMBank, or
- Transfer the funds using Internet Banking from your Beneficiary Bank to the provided IBAN details.

Once the funds have been cleared and your Term Deposit account is activated, your Relationship Manager will issue a Term Deposit Certificate. Please note that individuals will not have access to view the Term Deposit account via Internet Banking, as the Bank's Internet Banking platform is accessible to Corporate Customers only.
